WHEREAS SHIVVATI SHIVNANDAN SHUKLA MAHAVIDYLAYA, ARHOLI SEIKH, PUKHRAYAN, KANPUR DEHAT, UP, had applied for grant of recognition (UP-2526) for BTC course of two years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS the NRC its 126th meeting held on 20th 22th February, 2008. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent prior to recognition and ask the institution to Provide appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules, along with an Affidavit on the prescribed format on Rs. 100/- stamp paper from the Management of the institution and Affidavit on Rs. 10/- stamp paper from the staff appointed and staff list. After appointing the requisite faculty/staff shall put the information on its official website and also formally inform the Regional committee concerned. Accordingly letter of intent prior to recognition was issued to the institution on 26.02.2008.
- 4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in its 141st meeting held on 22nd 24th May, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
 - The list of appointed Faculty as per NCTE norms has not been submitted till date.
- 5. AND WHEREAS the committee decided to refused recognition for BTC. Course.
- NOW THEREFORE grant of recognition SHIVVATI SHIVNANDAN SHUKLA MAHAVIDYLAYA, ARHOLI SEIKH, PUKHRAYAN, KANPUR DEHAT- for the course in BTC Course is hereby refused.
