REFUSAL ORDER

WHEREAS SHAYAM LAL SARASWATI MAHAVIDAYLYA, SAASWATI VIHAR, SHIKARPUR, BULANDSHAR, U.P. had applied for grant of recognition (UP-2728) for B.ED. Additional intake of one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- AND WHEREAS the NRC its 139th meeting held on 10th 12th April, 2009. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent prior to recognition and ask the institution to Provide appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules, an affidavit on the prescribed format on Rs. 100/- stamp paper from the management of the institution is required to be submitted.(ii) the institution shall lunch its own website covering, inter alia, the details of the institution, its location, name of the course applied for with intake, availability of instructional facilities and the particulars of their proposed teaching and non teaching staff etc. (iii) the institution is asked to submit the selection committee minutes of faculty for exiting and proposed courses. Accordingly letter of intent prior to recognition was issued to the institution on 02.05.2009.
- AND WHEREAS the applicant institution has submitted reply dated 13.07.2009. The matter was placed in its 145th meeting held on 26th - 28th July, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
 - Minutes of selection committee are not submitted.
 - · Affidavit on stamp paper of Rs. 10/- by appointed Faculty and Rs. 100/- stamp paper by Management regarding appointment of Faculty are not submitted.
 - · Some of the appointed teachers are not the list of Faculty for M.Ed.
- AND WHEREAS the committee decided to refused accognition for B.ED. Additional intake. 5.
- NOW THEREFORE grant of recognition SHAYAM LAL SARASWATI MAHAVIDAYLYA. SAASWATI VIKAR, SHIKARPUR, BULANDSHAR, U.P. for the course in B.ED. Additional intake is hereby refused.
