REFUSAL ORDER

WHEREAS **SARASWATI HIGHER EDUCATION & TECHNICAL COLLEGE, VILL - GAHNI, PO- AYAR, VARANSAI, UP.** had applied for grant of recognition (UP - 2648) for B.P.ED. Additional intake of one year(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its **142nd meeting held on 14th - 16th August, 2009**, the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on **22.06.2009** to the applicant institution under proviso to section 15(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

4. AND WHEREAS the applicant institution had not submitted representation. The representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the NRC 145th Meeting held on 26th - 28th July, 2009 which came to the conclusion that recognition to the said institution be refused for the following reasons.

(a) **The reply of the institution has not received in the stipulated time.**

5. NOW THEREFORE grant of recognition to **SARASWATI HIGHER EDUCATION & TECHNICAL COLLEGE, VILL - GAHNI, PO- AYAR, VARANSAI, UP.** for the course in **B.P.ED. Additional intake** in term of section 15(3) (b) of the NCTE Act, 1993 is hereby refused.
