#### ORDER

WHEREAS, the RASIDA BEGAM MUSLIM MAHAVIDYALAYA, BIJNOR ROAD, AMROHA, J P NAGAR, UP. was granted recognition for running B.Ed. course of one year duration with an annual intake of 100 students, vide this office order no. F. NRC/NCTE/F-3/UP-739/3553-3561 dated 06.07.2004.

- 2. AND WHEREAS, the original file of the institution, VTR under section-13, as well as other documents, and other related documents, were considered by Northern Regional Committee in its 137<sup>th</sup> meeting held on 28<sup>th</sup> Feb -01<sup>st</sup> March, 2009, the committee decided to issue show cause notice under section 17 of NCTE Act, 1993 on the basis of observations and comments of the VT report given in the inspection report conducted under section 13, the committee further decided not to have inspection again. Accordingly SCN was issued on 27.03.2009 to the applicant institution under proviso to section 17 of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- 3. AND WHEREAS the applicant institution has submitted representation on 06.04.2009 The original file of the institution, reply of the institution, and other related documents, were again duly considered by Northern Regional Committee in its 140<sup>th</sup> meeting held on 25<sup>th</sup> 26<sup>th</sup> April, 2009, and committee observes that the reply submitted to the Show Cause Notice is not satisfactory. Hence the committee decided to withdraw recognition.
- 5. NOW THEREFORE grant of recognition RASIDA BEGAM MUSLIM MAHAVIDYALAYA, BIJNOR ROAD, AMROHA, J P NAGAR, UP. for the course in B.ED. is hereby withdraw.
