

ORDER

WHEREAS Sandesh College of Education, VPO-Karoli, Tehsil-Kosli, Distt-Rewari, Haryana of recognition (HR-1672) for B.Ed. course one years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- 2 AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- AND WHEREAS in its 137th meeting held on 28th Feb-01st March 2009 the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant Institution, was satisfied that the applicant institution does not fulfill the requirements and issued a notice on 12.03.2009 to the applicant institution under provision to section 14(3) (b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- 4 AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on **09.04.2009.** The said representation of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its **139**th meeting held on **10**th **-12**th **April 2009** the committee decided that recognition to the said institution be refused for the following reasons.
 - CLU is not issued by the competent authority on the prescribed format.
 - In response to our letter, the State Government recommendation in negative.



- NOW THEREFORE grant of recognition to Sandesh College of Education, VPO-Karoli, Tehsil-Kosli, Distt-Rewari, Haryana, for the course in B.Ed. in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993
