

#### REFUSAL ORDER

WHEREAS Prabba Devi Mahavidyalaya, Khalilahad, Distt. Sant Kabir Nagar, U.P. had applied for grant of recognition (UP-2140) for M.ED. Course of one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS the NRC its 112<sup>th</sup> meeting held on 27<sup>th</sup> 28<sup>th</sup> December, 2006. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a Conditional recognition order and ask the institution to Provide appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt./Affiliating University/Body given effect before the commencement of the M.Ed. course. Accordingly order was issued to the institution on 29.12.2006.
- 4. AND WHEREAS the applicant institution has submitted several replies and the matter finally placed in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> 24<sup>th</sup> May, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
  - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- AND WHEREAS the committee decided to refused recognition for M.ED. Course.
- NOW THEREFORE grant of recognition Prabha Devi Mahavidyalaya, Khalilabad, Distt. Sant Kabir Nagar, U.P. for the course in M.ED. is hereby refused.
