DEGREE COLLEGE, VILLAGE - TYOR, POST - BARRAULI, TEHSIL - CHHIBRAMAU, DISTT. - KANNAUJ, U.P. for conducting B.Ed. additional intake of Secondary (level) of one year duration with an annual intake of 100 (one hundred) students (existing 100+ additional 100 = 200) from the academic session 2008-2009 under clause 7(11) of NCTE Regulation 2007 notified on 10.12.2007 subject to fulfillment of the following:

- (i) The institution shall within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (iii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10.12.2007.
