REFUSAL ORDER

WHEREAS Narayan Arya Kanya Pathsala Post Graduate College, Sahab Ganj Narayan Das street, Farrukhabad, UP. had applied for grant of recognition (UP - 2963) for B.ED. Course of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 144th meeting held on 12th 14th July, 2009, the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 21.07.2009 to the applicant institution under provise to section 14(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
 - 4. AND WHEREAS the applicant institution had submitted representation. The representation of the institution as well as other documents and materials submitted by the Institution along with VTR and videography were again duly considered by the NRC 147^{th} Meeting held on $16^{th}-17^{th}$ August, 2009 which came to the conclusion that recognition to the said institution be refused for the following reasons.
 - (a) Faculty has not yet been appointed through duly constituted selection committee as per NCTE norms for B.ED
 - (b) Some facilities are still being proposed to be shared with students with other courses.
 - (c) Language learning facilities are still not adequate.
 - (d) The dimensions of Multipurpose Hall are not proper. The Multipurpose Hall is to be shared with students of other courses run by the College.
 - (e) The building plan having Khasra number is not approved by competent authority.
 - (f) The bill number 351 dated 04.07.2009 is the photocopy of old bill as the dates are written with blue pen on the photocopy and there is an over writing on the date under signature for Oxford Computers. Also the photocopy of this bill is also submitted. So it is a fraud.
 - (g) Other bills related to purchase of computers are old and no where it is mentioned that these are entered in the stock register.
