ORDER

WHEREAS **Awasthi Memorial School of Teacher Education, Vill-Dharamshala, Sham Nagar, Kangra, HP**, of recognition (**HP-312**) for **D.ED** course of Two years (2) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on **01.08.2008**.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its **148th** Meeting held on **28th to 30th August 2009** the committee decided that recognition to the said institution is refused for following reasons.

- The land has not been registered in the name of Institution within stipulated time as communicated to it. There is no reply of the Institution regarding registration of land in the name of Institution till date.

4. AND WHEREAS the committee decides to refuse recognition to **D.Ed.** course.

5. NOW THEREFORE grant of recognition to **Awasthi Memorial School of Teacher Education, Vill- Dharamshala, Sham Nagar, Kangra, HP** for the course in **D.ED** in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of Rs. 5.00 Lakhs bearing no. **8117312** and **FDR of Rs, 3.00** Lakhs bearing No. **8117364** are returned herewith.

6. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
