ORDER

WHEREAS In terms of Section 15(1) of the NCTE Act, 1993 Department of Physical Education, Choudhary Devi Lal University, Sirsa, Haryana, has submitted an application to the Northern Regional Committee of NCTE for grant of recognition/parmission for starting M.P.Ed. Course of Two years duration with an annual Intake of 30 (Thirty only) students on 29.05.2007.

- 2. AND WHEREAS a letter of Intent Prior to Recognition under clause 7(11) of the NCTE Regulation 2005 was issued to the applicant institution on 25.01.2008. The applicant institution had not submitted list of selected Faculty by duly constituted selection committee as required. The matter was placed in 141st meeting held on 22st to 24th May 2009, the original file of the institution, alongwith all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc were considered by the Committee and the Committee had decided to withdraw the conditional recognition granted to the Institution. Accordingly, Withdrawal Order was issued vide order No. F.NRC/NCTE/F-7-3/HR-877/2009/4188-4194 dated 10.06.2009.
- 3. AND WHEREAS the institution has preferred an appeal on 20.06.2009 against the withdrawal order of NRC dated 10.06.2009 to the appellate authority. The appeal of the institution was accepted and NRC's order dated 10.06.2009 was set aside by the appellate authority. The Council has reversed the order appealed against vide Order dated 07.08.2009.
- 4. NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Department of Physical Education, Choudhary Devi Lai University, Sirsa, Haryana for conducting M.P.Ed Course of Two years duration with an annual intake of 30 (Thirty only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007.
- The institution shall, within one month of the receipt of recognition order, convert the andowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
- Further, the recognition is subject to fulfillment of all such other requirements as may be
 prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC,
 the State Government etc, wherever applicable.
- 9. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
