WHEREAS SHRI MADHAV COLLEGE OF EDUCATION AND TECHNOLOGY, KESHAV NAGAR, MODI NAGAR MARG, HAPUR, GHAZIABAD-245101, UP. had applied for grant of recognition (UP-2405) for B.ED. Additional intake one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS the NRC its 121" meeting held on 16" 17" September, 2007. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter prior to grant of recognition and ask the institution to Provide appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules, along with an affidavit on the prescribed format on Rs. 100 stamp paper from the Management of the institution and affidavit on Rs. 10 stamp paper from the stamp appointed and piaff list. Accordingly letter prior to grant of recognition was issued to the institution on 22.09.2007.
- 4. AND WHEREAS the applicant institution has submitted several replies and the matter finally placed in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> 24<sup>th</sup> May, 2009. The original file of the institution, along with a'i other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
  - Permission from competent authority to run the college in the building which is approved to run school only is not submitted.
- AND WHEREAS the committee decided to refused recognition for B.Ed. Additional intake.
- 6. NOW THEREFORE grant of recognition SHRI MADHAV COLLEGE OF EDUCATION AND TECHNOLOGY, KESHAV NAGAR, MODI NAGAR MARG, HAPUR, GHAZIABAD-245101, UP, for in B.ED. Additional intake. In term of section 15(1) of the NCTE Act, 1993 is hereby refused.
