REFUSAL ORDER

WHEREAS DHANVANTRI EDUCATIONAL INSTITUTE, KHASRA NO.-18, 19, 20, MAUZA JALAL, FARAH, DISTT.-MATHURA, UP. had applied for grant of recognition (UP-3154) for B.ED course of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- AND WHEREAS the NRC its 144th meeting held on 12th 14th July, 2009. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent prior to recognition and ask the institution to Provide appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. An Affidavit on the prescribed format on Rs. 100/- stamp paper from the Management of the institution is required to be submitted. The institution shall lunch its own website covering, inter atia, the details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure, instructional facilities and the particulars of their proposed feaching and non - teaching staff etc. Accordingly letter of intent prior to recognition was issued to the institution on 024.08.2009.
- AND WHEREAS the applicant institution has submitted reply on behalf of website dated 27.07.2009; The matter was placed in its 146<sup>th</sup> meeting held on 05<sup>th</sup> 07<sup>th</sup> August, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCIE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
  - . As per letter dated 23,03,2009, the institution was directed to register the land in the name of institution within 90 days. This has not been done within the stipulated time.
  - The Faculty has not been selected through duly constituted selection committee as per NCTE Norms.
- AND WHEREAS the committee decided to refused recognition for B.F.D Course.
- NOW THEREFORE grant of recognition DHANVANTRI EDUCATIONAL INSTITUTE, KEASRA NO.-18, 19, 20, MAUZA JALAL, FARAH, DISTT.-MATHURA, UP. for the course in B.ED. Course is hereby refused.
