- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- AND WHEREAS the NRC its 109th meeting (Second sitting) and 110th meeting on 10th November, 2006 and 11th - 12th November, 2006 at NCTE Hurs. New Delhi, considered application of the institutions and after careful examination of relevant documents. Visiting Team Reports, Video Recording, Original file etc. found the institutions fit for grant recognition of the B.P.ED. Course subject to the condition of appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt./ Affiliation University/Body given effect before the commencement of the course.
