REFUSAL ORDER



WHEREA. CAREER COLLEGE OF MANAGEMENT & EDUCATION, SECTOR - 5, VIKAS NAGAR, LUCKNOW-2260/22, UP. had applied for grant of recognition (UP-2289) for B.Ed. course of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND VIEREAS the competent authority has constituted a Visiting Team to Visit the institution and Le visiting team had since submitted its report.
- AND WHEREAS the NRC its 118th meeting held on 16th 17th June, 2007. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent prior to Recognition and ask the institution to provide (i) appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules, an affidavit on the prescribed format on Rs.100/- stamp paper from the Management of the institution is required to be submitted. (ii) The institution shall launch its own website covering, inter alia, the details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure and instructional facilities and the particulars of their proposed teaching and non teaching staff etc. Accordingly letter was issued to the institution on 17.09.2009.
 - 4. AND WHEREAS the applicant institution has submitted reply dated 15.01.2009. The matter was placed in its 141st meeting held on 22^{std} 24th May, 2009. As per the above observation of NRC vide letter dated 01.06.2009 the institution was asked to submit clarification within 21 days and the institution submitted reply on 18.06.2009, and the matter was placed in its 143^{cd} meeting held on 27th 29th June, 2009. The original file of the institution, along with all other related documents, affidavits. Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
 - The affidavit from each appointed Faculty on stamp paper of Rs. 10/- is not submitted.
 - In response to observation of the NRC regarding the term of the principal was over in 2008, the institution has submitted letter dated 07.12.2007 which is not valid.
 - 5. AND WHEREAS the committee decided to refused recognition for B.Ed. Course.
 - NOW THEREFORE grant of recognition to CAREER COLLEGE OF MANAGEMENT & EDUCATION, SECTOR - 5, VIKAS NAGAR, LUCKNOW-226022, UP. for the course in B.Ed. Course is hereby refused.
