REFUSAL ORDER

WHEREAS Department of Education University of Lucknow, Lucknow, UP. had applied for grant of recognition (UP-972) for M.ED course of two years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS the NRC its 126<sup>th</sup> meeting held on 20<sup>th</sup> 22<sup>nd</sup> February, 2008. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter prior to grant of recognition and ask the institution to Provide appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules, along with an affidavit on the prescribed format on Rs. 100 stamp paper from the Management of the institution and affidavit on Rs. 10 stamp paper from the statist appointed and staff list. Accordingly letter prior to grant of recognition was issued to the institution on 03.03.2008.
- 4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in its 142<sup>nd</sup> meeting held on 14<sup>th</sup> 16<sup>th</sup> June, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
  - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- 5. AND WHEREAS the committee decided to refused recognition for M.ED Course.
- NOW THEREFORE grant of recognition Department of Education University of Lucknow, Lucknow, UP, for the course in M.ED Course is hereby refused.
