REFUSAL ORDER

New Delhi, considered application of the institutions and after careful examination of relevant documents, Visiting Team Reports, Video Recording Original file etc. found the institutions fit for grant recognition of the B.P.ED. Course subject to the condition of appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt./ Affiliation University/Body given effect before the commencement of the course."
