

#### REFUSAL ORDER

WHEREAS D.A.V. COLLEGE, KHARKHAUDA, MEERUT, UP, had applied for grant of recognition (UP-2490) for M.ED course of one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting term had since submitted its report.
- 3. AND WHEREAS the NRC its 131<sup>st</sup> (3<sup>rd</sup> sitting) meeting held on 29<sup>th</sup> 31<sup>st</sup> August, 2008. The Northern Regional Committee after considering the report of the visiting team as well as other relevan, materials furnished by the applicant institution decided to issue a letter of intent prior to recognition and ask the institution to Provide appointment of faculty/staff by a only constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. An affidavit on the prescribed format on Rs. 160/- stamp paper from the Management of the institution is required to be submitted. (ii) the institution shall launch its own website covering, inter alia, the details of the institution, its location, name of the course applied for with intake availability of physical infrastructure and instructional facilities and the particulars of their proposed teaching and non—leaching staff etc. Accordingly letter prior to grant of recognition was issued to the institution on 04.6°, 2008.
- 4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in its 141<sup>th</sup> meeting held on 22<sup>th</sup> 24<sup>th</sup> May, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993. Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
  - The last of appointed Faculty as per NCTF. Norms has not been submitted till
    date.
- 5. AND WHEREAS the committee decided to refused recognition for M.ED Course.
- 6. NOW THEREFORE gran of recognition D.A.V. COLLEGE, KHARKHAUDA, MEERUT, UP. for the course in M: D Course is foreby refused.
