#### REFUSAL ORDER

WHEREAS VINAYAK VIDYAPEETH NH-58, VILL-PAWLI KHAS, PO- MODIPURAM, TEH-SARDHANA, DISTT- MEERUF-250005 UP, had applied for grant of recognition (UP-3015) for B.Ed course of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 144th meeting held on 12th 14th July, 2009. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution and committee decided to issue a letter of intent prior to recognition and ask the institution to (1) appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. An affidavit on the prescribed format on Rs. 100/- stamp paper from the Management of the institution is required to be submitted. (ii) the institution shall launch its own website covering, inter alia, the details of the institution, its location, name of the course applied for with intake, availability of instructional facilities and the particulars of their proposed teaching and non—teaching staff etc. Accordingly letter of intent prior to recognition was issued to the institution on 23.07.2009.
- 4. AND WHEREAS the applicant institution has submitted reply dated 25.07.2009. The matter was placed in NRC in its 146<sup>th</sup> meeting held on 5<sup>th</sup> 7<sup>th</sup>August, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
  - As per letter dated 2-5-2009, the institution was directed to register the land in the name of institution within 90 days. This has not been done within the stipulated time.
  - As per approved list of the faculty the affiliating university, there is no faculty to teach Physics, Chemistry, Biology, Mathematics, Science, etc.
- AND WHEREAS the committee decides to refused recognition for B.Ed. Course.
- NOW THEREFORE grant of recognition to VINAYAK VIDYAPEETH NH-58, VILL-PAWLI KHAS, PO- MODIPURAM, TETI- SARDHANA, DISTT- MEERUT-250005 UP. for the course in BEd. is hereby religied.
