REFUSAL ORDER

17 SEP 2009

WHEREAS VIDYARTHI SNATAK MAHAVIDYALAYA, JAGADISHPUR BARDIHA, POST. JAGADISHPUR DHARMDANI, KUSHINAGAR, UP. had applied for grant of recognition (UP-2134) for BTC. Course of two years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 113rd meeting held on 18th - 19th November, 2007. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided fit for grant of recognition of the course and intake subject to the condition of appointment to qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt. / Affiliating University/ Body given effect before the commencement of the course etc. Accordingly order was issued to the institution on 24.01.2007.

4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 141st meeting held on 22nd -24th May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE. Published from time to time, etc. were considered and the committee observes that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

5. NOW THEREFORE grant of recognition to VIDYARTHI SNATAK MAHAVIDYALAYA, JAGADISHPUR BARDIHA, POST. JAGADISHPUR DHARMDANI, KUSHINAGAR, UP. For the course in BTC, is hereby refused.

6. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
