- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- AND WHEREAS the NRC its 113" meeting held on 18th 19th November, 2007. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided fit for grant of recognition of the course and intake subject to the condition of appointment to qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt. / Affiliating University/ Body given effect before the commencement of the course etc. Accordingly order was issued to the institution on 24,01,2007.
