#### REFUSAL ORDER

2 5 SEP 2009

WHEREAS IDEAL COLLEGE OF EDCUATION GOVINDPURAM, GHAZIABAD-201003 U.P. Had applied for grant of recognition (UP-1667) for B.TC. Course two years(s) duration under section 15(1) of the NCTE Act. 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 104th meeting held on 15th 17th July, 2006. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution and committee decided to issue a letter of conditional recognition and ask the institution to appointment of staff by a duly constituted selection committee and ensure selection of candidates possessing qualification as prescribed under rules. However in case duly qualified staffs are not available, relaxation in terms of the requirement relating to passing of NET/SLET/Ph.D. etc., the institution may approach to the NCTE as per the NCTE Regulation 2005. Accordingly letter of conditional recognition was issued to the institution on 26.07.2006.
- 4. AND WHEREAS the applicant institution has not submitted proper reply. The matter was placed in NRC in its 141<sup>st</sup> meeting held on 22<sup>std</sup> -24<sup>th</sup> May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:
  - . The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- AND WHEREAS the committee decided to refused recognition for BTC. Course.
- NOW THEREFORE grant of recognition to IDEAL COLLEGE OF EDCUATION GOVINDPURAM, GHAZIABAD-201003 U.P. for the course in BTC. is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
