- AND WHEREAS the NRC its 112th meeting held on 27th & 28th December, 2006, The 3. Northern Regional Committee after considering the report of the visiting team as well as other relevant materials. Video Recording, Original file etc. as per the case found the institutions mentioned in fit for grant of recognition of the B.ED. Course subject to the condition of appointment to qualified staff through duly constituted selection committee as per the norms of NCTE / State Government/ Affiliating University/ Body given effect before the commencement of the course etc. Accordingly letter of conditional recognition was issued to the institution on 29.12.2006.
- AND WHEREAS the applicant institution has not submitted proper reply. The matter was placed in its 141st meeting held on 22nd - 24th May, 2009.  - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- AND WHEREAS the committee decided to refused recognition for B.ED. Course.
- NOW THEREFORE grant of recognition to Rani Bhagyawati Devi Mahila Mahavidyalaya, Bijnor, UP. for in B.ED course is hereby refused.
