REFUSAL ORDER

WHEREAS **Rani Bhagyawati Devi Mahila Mahavidyalaya, Bijnor, UP.** had applied for grant of recognition (T/P-2003) for B.ED course one years(s) duration under section 14(I) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 112th meeting held on 27th & 28th December, 2006, The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials, Video Recording, Original file etc. as per the case found the institutions mentioned in fit for grant of recognition of the B.ED. Course subject to the condition of appointment to qualified staff through duly constituted selection committee as per the norms of NCTE / State Government/ Affiliating University/ Body given effect before the commencement of the course etc. Accordingly letter of conditional recognition was issued to the institution on 29.12.2006.

4. AND WHEREAS the applicant institution has not submitted proper reply. The matter was placed in its 141st meeting held on 22nd - 24th May, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

5. AND WHEREAS the committee decided to refused recognition for B.ED. Course.

6. NOW THEREFORE grant of recognition to **Rani Bhagyawati Devi Mahila Mahavidyalaya, Bijnor, UP.** for in B.ED course is hereby refused.
