WHEREAS Bankey Biharl College of Technology, Artoni, Jayupura Road, Agra-282007, Uttar Pradesh had applied for grant of recognition (UP - 2440) for additional intake in B.Ed. course one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 123<sup>rd</sup> meeting held on 19-22 November 2007 the Northern Regional Committee after considering the report of the visiting learn as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice to the applicant institution under provise to section 14(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the sald applicant institution to make a written representation in this behalf.
- 3. AND WHEREAS the applicant institution had submitted representation dated 15.4.2007. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by Northern Regional Committee on 9th -10th April 2008 wherein the committee decided that fresh inspection of the institution be conducted to verify the facts claimed by the institution in its written representation.
- AND WHEREAS the competent authority had constituted a Visiting Team to second visit the institution and the visiting team had since submitted its report.
- 5. AND WHEREAS in its 135<sup>th</sup> meeting held on 22-23 December 2008 and adjourned meeting on 29<sup>th</sup> -30<sup>th</sup> December 2008 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements which came to the conclusion that recognition/ permission to the said institution be refused for the following reasons:
  - As per VT Report, the building shown for B.Ed., additional is used as Hostel.
  - . The Management has not shown building where B.Ed. and B.P.Ed. course is run.
  - There is no Science, Social Science, Work Experience Lab.
  - The rooms B.Ed for the Hostel where being prepared but building where B.Ed. and B.P.Ed. courses are run. The rooms of labs are without proper furniture.
  - The Books in the library are 1500-1800 not adequate.
  - Most of the books are not useful for teacher education.
- NOW THEREFORE grant of recognition to Bankey Bihari College of Technology, Artoni, Jayupura Road, Agra-282007, Uttar Pradesh for the course in B.Ed. additional intake in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
