REFUSAL ORDER

WHEREAS **Noble College of Professional Studies, Near LLRM Medical College, Garh Road, Meerut, UP.** had applied for grant of recognition (UP-2209) for B.ED course of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 119<sup>th</sup> meeting held on 28<sup>th</sup> - 31<sup>st</sup> July, 2007. The Northern Regional Committee after careful examination of relevant documents, agreed to grant recognition to the B.Ed. course under Article 7(11) of the NCTE Regulation dated 13<sup>th</sup> January, 2006 subject to the condition of the appointment of qualified staff as per NCTE norms through properly constituted Selection Committee for issuance of Unconditional Recognition order. Accordingly, letter prior to grant of recognition was issued to the institution on 03.08.2007.

4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> - 24<sup>th</sup> July, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

5. AND WHEREAS the committee decided to refused recognition for B.ED Course.

6. NOW THEREFORE grant of recognition to **Noble College of Professional Studies, Near LLRM Medical College, Garh Road, Meerut, UP.** for the course in B.ED Course is hereby refused.

7. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993
