- 3. AND WHEREAS the NRC its 114th meeting held on 21st 22nd February, 2007. The Northern Regional Committee after careful examination of relevant documents, Replies received from the institution, Visiting Team Reports, Video Recording, Original File etc, as per the case found the institutions fit for grant of recognition of the B.ED. Course. Subject to the condition of appointment of qualified smill through duly constituted selection committee as per the norms of NCTE/State Govt. / Affiliating University/ Body given effect before the commencement of the course etc. Accordingly letter of conditional recognition was issued to the institution on 23.02.2007.
- 4. AND WHEREAS the applicant institution has submitted reply. The matter was placed in its 141st meeting held on 22nd 24th July, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
 - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- AND WHEREAS the committee decided to refused recognition for B.ED Course.
- NOW THEREFORE grant of recognition to Dayawanti Punj Training Institute,
 Village and Post Sitamarhi, District Sant Ravi Das Nagar (Bhadohi) UP. for the course in B.ED Course is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993
