REFUSAL ORDER

26 SEP 2009

WHEREAS **A.K. College, Station Road, Sheikhabad, District - Firozabad, UP.** had applied for grant of recognition (UP-1545) for BTC course of two years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 119th meeting held on 28th - 30th July, 2008. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent prior to recognition and ask the institution to appoint the staff as per NCTE norms i.e. the Selection Committee is to be constituted as per policy of the state Government/Affiliation University/Affiliating Body/UGC. (ii) The institution are required to submit an affidavit on Rs. 100/- Stamp paper from the Management of the institutions and affidavit on Rs. 10/- stamp paper from the staff appointed. Accordingly letter of intent prior to recognition was issued to the institution on 03.08.2007.

4. AND WHEREAS the applicant institution has submitted reply. The matter was placed in its 141st meeting held on 22nd - 24th July, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

5. AND WHEREAS the committee decided to refused recognition for BTC Course.

6. NOW THEREFORE grant of recognition **A.K. College, Station Road, Sheikhabad, District - Firozabad, UP.** for the course in BTC Course is hereby refused.
