REFUSAL ORDER

26 SEP 2009

WHEREAS **Amar Singh Snatak Mahavidyalaya, Kaurapur Guara, Deeh, Rai Bareilly, Uttar Pradesh.** had applied for grant of recognition (UP-2222) for B.ED course of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 120th meeting held on 12th - 13th May, 2007. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue recognition order under 7(12) with condition to submit the Affidavit on Rs. 100/- stamp paper about the staff. Accordingly subject to submission letter was issued to the institution on 06.09.2007.

4. AND WHEREAS the applicant institution has submitted reply. The matter was placed in its 141st meeting held on 22nd - 24th July, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993. Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

5. AND WHEREAS the committee decided to refused recognition for B.ED Course.

6. NOW THEREFORE grant of recognition **Amar Singh Snatak Mahavidyalaya, Kaurapur Guara, Deeh, Rai Bareilly, Uttar Pradesh.** for the course in B.ED Course is hereby refused.

7. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993
