- 3. AND WHEREAS the NRC its 120<sup>th</sup> meeting held on 12<sup>th</sup> 13<sup>th</sup> May, 2007. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue recognition order under 7(12) with condition to submit the Affidavit on Rs. 100/- stamp paper about the staff. Accordingly subject to submission letter was issued to the institution on 06.09,2007.
- 4. AND WHEREAS the applicant institution has submitted reply. The matter was placed in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> 24<sup>th</sup> July, 2009. Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:

    Kaurapur Guara, Deeh, Rai Bareilly, Uttar Pradesh. for the course in B.ED Course is hereby refused.
  - If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993
