REFUSAL ORDER

WHEREAS Modern College of Professional Studies, 431, Anand Industrial Area, Mohan Nagar, Ghaziabad, UP. had applied for grant of recognition (UP-2570) for M.E.D course of one years(s) duration under section 15(1) of the NCTE Act. 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS the NRC its 125th meeting held on 21st 22nd January, 2008. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent prior to recognition and ask the institution to appointment of faculty/staff by a duly constituted selection committee and ensures selection of candidates possessing qualification as prescribed under rules. Along with an affidavit on the prescribed format on Rs. 100/- stamp paper from the Management of the institution and Affidavit on Rs. 10/- stamp paper from the staff appointed and staff list. Accordingly letter of intent prior to recognition was issued to the institution on 25.01,2008.
- 4. AND WHEREAS the applicant institution has submitted reply date 05.12.2008. The reply was examined and it was observed that the following condition / requirements have not been fulfilled:-
 - The institution is required appoint one Professor other than the Principal of B.Ed.
 course. If Principal of B.Ed. course has been selected as Professor separate Principal
 is to be appointed and details to be submitted on affidavit Rs. 100/- stamp paper.
- AND WHEREAS, letter was issued on 24.02.2009.
- 6. AND WHEREAS the applicant institution has not sebmitted reply. The matter was placed in its 141st meeting held on 22nd 24th July, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
