- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the 2. institution and the visiting team had since submitted its report.
- AND WHEREAS the NRC its 111th meeting held on 30th November and 01st December, 2006 at NCTE Hqrs. New Delhi, considered application of the institutions and after careful examination of relevant documents, Visiting Team Reports, Video Recording, Original file etc. found the institutions fit for grant recognition of the B.ED. Course subject to the condition of appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt./ Affiliation University/Body given effect before the commencement of the course. Accordingly order was issued to the institution on 02.12.2006, and 27.02.2008.

- AND WHEREAS the committee decided to refused recognition for B.ED Course. 5.
- NOW THEREFORE grant of recognition to DADHTCHT COLLEGE OF HIGH EDUCATION, N- POCKET, DADHICHI ROAD, GANGA NAGAR, MAWANA ROAD, MEERUT, up, for the course in B.E.D. In term of section 14(1) of the NCTE Act, 1993 is hereby refused.
