#### REFUSAL ORDER

WHEREAS BASANT RAM NAGEENA MAHAVIDYALAYA, VPO -DHARAON, CHANDAULI, UP. had applied for grant of recognition (UP - 2829) for B.Ed. course of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- AND WHEREAS in its 143rd meeting held on 27th 29th June, 2009, the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 03.07.2009 to the applicant institution under provise to section 14(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf,
- AND WHEREAS the applicant institution had submitted representation on 30.07.2009, to Northern Regional Committee, NCTE. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the NRC 147th Meeting held on 16th - 17th August, 2009 which came to the conclusion that recognition to the said institution be refused for the following reasons.
  - Faculty has not yet been appointed through duly constituted (a) selection committee as per NCTE norms for B.ED.

Language learning facilities are still not adequate. (b)

- The number of titles in the library is not as per NCTE norms. (c)
- NOW THEREFORE grant of recognition to BASANT RAM NAGEENA MAHAVIDYALAYA, VPO - DHARAON, CHANDAULI, UP. for the course in B.Ed. course is hereby refused.
