#### REFUSAL ORDER

WHEREAS R.S.S DEGREE COLLEGE, SAIDPUR BALDEO, MATHURA, UP. had applied for grant of recognition (UP - 3120) for M.Ed. course of one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- AND WHEREAS in its 145th meeting held on 26th 28th July, 2009, the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 14.08.2009 to the applicant institution under proviso to section 15(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- AND WHEREAS the applicant institution had submitted representation on 11.09.2009, to Northern Regional Committee, NCTE. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the NRC 149th Meeting held on 13th - 14th September, 2009 which came to the conclusion that recognition to the said institution be refused for the following reasons.
  - Identification of Faculty for M.Ed. course. (a)

Development of separate facilities for M.Ed. (b)

Having number of titles in the library as per NCTE norms for M.Ed. (c)

Availability of E- learning facility for M.Ed. course. (d)

NOW THEREFORE grant of recognition to R.S.S DEGREE COLLEGE, SAIDPUR BALDEO, MATHURA, UP. for the course in M.Ed. course is hereby refused.
