ORDER

WHEREAS **Sardar Rajinder Singh Memorial Mukat College of Education, Damanheri Road, Patiala- Rajpura Bye Pass, Rajpura, Punjab**, of recognition (PB-356) for B.ED course of One years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on **30.10.2007**.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its 104th Meeting held on **15th to 17th July 2006**, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied that the committee decided to issued conditional recognition to the applicant institution on **24.07.2006** and clarification issued on **02.06.2009**.

4. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE. The original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 148th Meeting held on **28th to 30th August 2009** the committee decided that recognition to the said institution is refused for following reasons.

- The deficiency communicated to the college regarding appointment of Faculty is not removed within stipulated time.

5. AND WHEREAS the committee decides to refuse recognition for B.Ed. course.

6. NOW THEREFORE grant of recognition to **Sardar Rajinder Singh Memorial Mukat College of Education, Damanheri Road, Patiala- Rajpura Bye Pass, Rajpura, Punjab** for the course in B.ED in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of Rs. 5.00 Lakhs bearing no. **401607** is returned herewith.

7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
