REFUSAL ORDER

WHEREAS Shri Vijay Swaroop Mahila College of Education, Sector -12, Sikandra, Agra, UP. had applied for grant of recognition (UP-2538) for BTC. Course two years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the Institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 127th meeting held on 27th - 29th March, 2008. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent prior to recognition and ask the institution to appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules, along with an Affidavit on the prescribed format on Rs. 100/- stamp paper from the Management of the institution and Affidavit on Rs. 10/- stamp paper from the Staff appointed and staff list. Accordingly letter of intent prior to recognition was issued to the institution on 7.04.2008.

4. AND WHEREAS the applicant institution has submitted reply. The matter was placed in NRC in its 134th meeting held on 20th -22nd November, 2008. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:

- Affidavit on Rs. 100/- Stamp paper from each staff member on the prescribed format and attested copies of experience certificate of Principle and certificate of faculties required.

Accordingly clarification letter was issued to the institution on 01.12.2008.

5. AND WHEREAS the applicant institution has not submitted proper reply. The matter was placed in NRC in its 141st meeting held on 22nd -24th May, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

6. AND WHEREAS the committee decided to refused recognition and return FDRs if submitted.

7. NOW THEREFORE grant of recognition **Shri Vijay Swaroop Mahila College of Education, Sector -12, Sikandra, Agra, UP.** for the course in B.T.C is hereby refused.

8. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
