NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to SETH SRINIWAS AGARWAL INSTITUTE OF HANAGEMENT, 775, RAGDAUDHI KACCHAR, G.T. ROAD, NARAMAN, DISTT. KANPUR NAGAR, U.P. for conducting B.Ed. Course of Secondary (level) of one year duration with an abnual intake of 100 (One Hundred) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions as per the clarification from the NCTE Hers letter no. file No. 48-3(1)/2008/NCTE (N&S) dated 01/10/2009:-

The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date of prescribed by the examining body for the academic session 2009-2010, falling which the recognition will be effective from the academic session 2010-2011 only.

 Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating body.

4. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
