ORDER

WHEREAS Balaji College of Education, VPO-Hansi, Tehsil-Hansi, Distt-Hissar, Haryana of recognition (HR-1245) for B.Ed. course one years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- 2 AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- AND WHEREAS In its 137th meeting held on 28th Feb-01st
 March 2009 the Northern Regional Committee after considering the
 report of the visiting as well as other relevant materials furnished by
 the applicant institution, was satisfied that the applicant institution
 does not fulfill the requirements and issued a notice on 12.03.2009 to
 the applicant institution under provision to section 14(3) (b) of the
 NCTE Act, 1993 thereby giving an opportunity to the said applicant
 institution to make a written representation in this behalf.
- 4 AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on 09.04.2009. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in 112 139th meeting held on 10th -12th April 2009 the committee decided that recognition to the said institution be refused for the following reasons.
 - The reply of the Institution in respect of CLU and registration of land in the name of Institution has not been received. Also the State Government recommendation based on reasons and with necessary statistics is negative.

- 5 NOW THEREFORE grant of recognition to Balaji College of Education, VPO-Hansi, Tehsil-Hansi, Distt-Hissar, Haryana, for the course in B.Ed. in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.
- 6 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993
