AND WHEREAS in its 101st meeting held on 22nd 24th February, 2006, the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 14.03.2006 to the applicant institution under proviso to section 15(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- 4. AND WHEREAS the applicant institution had not submitted representation. The matter was Placed in its 124th (1st Sitting) meeting held on 17th 19th December, 2007. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to final intimation letters to be issued before closing the file. To ask for the reply within a month. Accordingly final intimation notice was issued to the institution on 02.02.2008.
- 5. AND WHEREAS the applicant institution had not submitted representation. The institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the NRC 140^{th} Meeting held on $25^{th}-26^{th}$ April, 2009 which came to the conclusion that recognition to the said institution be closed for the following reasons.
- Deficiencies communicated in the deficiency letter issued by the office are not removed within stipulated period.
 - NOW THEREFORE grant of recognition to Shabari Balika Mahavidyalaya, VPO - Sikhari, Via - Dullahapur, District - Ghazipur, UP. for the course in BTC course in term of section 15(3) (b) of the NCTE Act, 1993 is hereby closed.
