**REFUSAL ORDER**

WHEREAS District Institute of Education and Training, Ismailpur, District – Bijnor, UP, had applied for grant of recognition (UP-1030) for BTC Additional intake of two years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 104<sup>th</sup> meeting held on 15<sup>th</sup> – 17<sup>th</sup> July, 2006. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of conditional recognition and ask the institution to provide Appointment of staff by a duly constituted selection committee and ensure selection of candidates possessing qualification as prescribed under rules. However in case duly qualified staff is not available, relaxation in terms of the requirement relating to passing of NET/SLET/Ph.D. etc. the institution may approach to the NCTE as per the NCTE Regulations. Accordingly letter of conditional recognition was issued to the institution on 25.07.2006.

4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> – 24<sup>th</sup> May, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

5. AND WHEREAS the committee decided to refused recognition for BTC Additional intake.

6. NOW THEREFORE grant of recognition District Institute of Education and Training, Ismailpur, District – Bijnor, UP, for the course in BTC Additional intake is hereby refused.
