

REFUSAL ORDER

WHEREAS Mahalakshmi College for Girls, 11, K.M. Mile Stone, Delhi Meerut Road, Duhai, Ghaziabad, UP, had applied for grant of recognition (UP-2688) for B.ED Additional intake of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS the NRC its 139th meeting held on 10th 12th April, 2009. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to grant recognition under clause 7(11) of Regulations 2007 subject to submission of letter of the University regarding nomination of subject expert on the selection and submission of letter of permission regarding increase in hall size from Gaziabad Development Authority. Accordingly clarification letter was issued to the institution on 02.05.2009.
- 4. AND WHEREAS the applicant institution has submitted reply dated 09.06.2009. The matter was placed in its 143rd meeting held on 27th 29th June, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
 - The University nominee as per minutes of selection committee dated 30th July 2008 is Mrs. Rani Saini Verma but according to the University letter dated 20 June 2008 the University nominee should have been Dr. Poonam Pnadey. Thus, the selection committee was not valid.
- AND WHEREAS the committee decided to refused recognition for B,ED Additional intake.
- NOW THEREFORE grant of recognition Mahalakshmi College for Girls, 11, K.M. Mile Stone, Delhi Meerut Road, Duhai, Ghaziabad, UP. for the course in B.ED Additional intake is hereby refused.
