

REFUSAL ORDER

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 RAMA INSTITUTE OF HIGHER EDUCATION, 1, K.M., STONE, NAJIBAD ROAD, KIRATPUR, BIJNOR, U.P. had applied for grant of recognition (UP-2752) for M.ED. course of One year duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the Competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- AND WHEREAS in its 129<sup>st</sup> meeting held on 7<sup>th</sup> to 9<sup>th</sup> May 2008 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and the committee decided to Issue a letter of conditional Recognition on 13.05.2008 to the applicant institution under proviso to section 15(3) (b) of the NCTE Act, 1993.
- 4. AND WHEREAS the applicant institution has not submitted proper reply. The matter was placed before Northern Regional Committee in its 149th Meeting held on 13th - 14th September 2009. The original file of the institution along with all other related documents, affidavits Act of NCTE 1993, Regulations and Guidelines of NCTE published from time to time etc. were considered and the committee observed that:-
  - Dr. Arun Mishra, Ms Seema Gupta and Ms. Niharika Rathore do not have qualification as per NCTE norms for M.Ed.
- Hence, the committee decides to refuse recognition to M.Ed.
- NOW THEREFORE the application of RAMA INSTITUTE OF HIGHER EDUCATION, 1, K.M., STONE, NAJIBAD ROAD, KIRATPUR, BIJNOR, U.P. for the course in M.ED. is hereby refused.
