## ORDER

WHEREAS Smt. Bhagwani Memorial Institute of Higher Education, Bansi Vidya Niketan Sohana, Samirpur Road, Rajiv Colony, Sector-56, Ballabgarh, Faridabad, Haryana had applied for grant of recognition (HR-411) for B.Ed. course one year duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 10.04.2006.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution on 04.11.2006 and the visiting team had since submitted its report.
- 3. AND WHEREAS In its 111<sup>th</sup> meeting held on 30<sup>th</sup> November 01<sup>st</sup> December 2006 the Northern Regional Committee after careful examination of relevant documents, reply received from the institution, visiting team reports, video recording, original file etc, has found the institution fit for grant of recognition for B.ED. Course subject to the condition of appointment of qualified staff through-duly constituted selection committee as per the norms of NCTE/State Govt./ Affiliating University/ body given effect before the commencement of the course
- 4. AND WHEREAS the applicant institution had submitted reply on 28.12.06. The same was examined it was observed that the following conditions/ requirements have not been full filled.
  - The Institution has appointed Principal but not qualified as per NCTE norms. Hence the institution is required to appoint qualified Principal as per NCTE norms
- 5. AND WHEREAS in its 146<sup>th</sup> meeting held on 05<sup>th</sup> -07<sup>th</sup> August 2009 the Northern Regional Committee, the original file, reply of the Institution and alongwith all other related documents, Act of NCTE 1993, Regulations and Guidelines of NCTE Published from time to time were considered by the Northern Regional Committee and observes the following:
  - Dr. Shambhu Sharan as Principal has not been selected through duly constituted selection committee as per NCTE norms for B.ED. Further, he does not have experience as per NCTE norms for B.Ed.

Hence, the committee decided to refuse recognition for B.ED. Course.

 NOW THEREFORE grant of recognition to Smt. Bhagwani Memorial Institute of Higher Education, Bansi Vidya Niketan Sohana, Samirpur Road, Rajiv Colony, Sector-56, Ballabgarh, Faridabad, Haryana for the course in B.Ed. in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.
