- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- 3. AND WHEREAS in its 134th Meeting held on 20th to 22nd November, 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution was issued conditional recognition on 27.08.2006 and clarification letter was issued on 01.12.2008.
- 4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE. The matter was placed in 141st meeting which was held on 22nd to 24th May, 2009. The original file of the institution, along with all other related documenst, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc., were considered and the committee observes that:
 - The list of Faulty selected by duly constituted selection committee as per NCTE norms is not submitted i.e. affidavit are not on prescribed formats.
 - · One teacher on contact basis.
- AND WHEREAS the committee decided to with draw the conditional recognition granted to the institution. Accordingly withdrawal order was issued 09.06.2009.
- 6. AND WHEREAS the institution had preferred an appeal to the NCTE Hqrs. The appellate authority has remanded back the case to NRC for issue of a revised order specifying that the withdrawal of conditional recognition accorded to the institution vide NRC's order dated 09.06.09 would be effective from the academic session 2009-2010. Accordingly, the case was remanded back to the NRC for issue of revised order.
