- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- 3. AND WHEREAS in its 109<sup>th</sup> (II sitting) of NRC held on 10<sup>th</sup> November, 2006 & 11-12 November, 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, was satisfied that the application was issued clarification letter on 02.11.2007
- 4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTF by 22.05.2009. The matter was placed in 141<sup>st</sup> meeting which was held on 22<sup>st</sup> to 24<sup>st</sup> May, 2009, the original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc., were considered and the committee observes that:
  - The documents sought regarding appointment of Faculty are not submitted.
- AND WHEREAS the committee decided to with draw the conditional recognition granted to the institution. Accordingly withdrawal-order was issued 15.06,2009.
- 6. AND WHEREAS the institution had preferred an appeal to the NCTE Hqrs. The appellate authority has remanded back the case to NRC for issue of a revised order specifying that the withdrawal of conditional recognition accorded to the institution vide NRC's order dated 15.06.09 would be effective from the academic session 2009-2010. Accordingly, the case was remanded back to the NRC for issue of revised order.
