ORDER

WHEREAS **BABA BALAK NATH COLLEGE OF EDUCATION, VPO – BAROA, TEHSIL – JAWALAJI, DISTT. – KANGRA, HP**, of recognition (**HP-289**) for **B.ED** course of One years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on **28.03.2008**.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its **148th** Meeting held on **28th to 30th August 2009**, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied that the committee decided to issued **Sh. w Cause Notice** to the applicant institution on **31.08.2009**.

4. AND WHEREAS the applicant Institution has submitted representation to Northern Regional Committee, NCTE. The original file of the Institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its **150th** Meeting held on **09th to 11th October 2009** the committee decided that recognition to the said Institution is refused for following reasons.

- There is a negative recommendation of the Himachal Pradesh Govt. regarding opening of new B.Ed. college in the Kangra District and therefore, recognition cannot be granted as per NCTE norms.

5. AND WHEREAS the committee decides to Close the File, and the FDR in original, if any may be returned.

6. NOW THEREFORE grant of recognition to **BABA BALAK NATH COLLEGE OF EDUCATION, VPO – BAROA, TEHSIL – JAWALAJI, DISTT. – KANGRA, HP** for the course in **B.ED** in term of section 14(3)(b) of the NCTE Act, 1993 is hereby Closed. The FDR of Rs. **5.00 Lakhs** bearing no. **885236** & the FDR of Rs. **3.00 Lakhs** bearing No. **558260** are returned herewith.

7. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
