REFUSAL ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 COLLEGE OF AAPLIED EDUCATION & HEALTH SCIENCE KRISHNA NAGAR PAC, MEERUT PLOT NO. A - 122, GANGOTRI COLONY, TEHSIL - SARDHANA, ROORKEE ROAD MEERUT, UP, had applied for grant of recognition (UP-3027) for B.ED. Course of one year duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 11.6.2008

- AND WHEREAS the Competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 146th meeting held on 5th to 7th August 2009 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a show cause notice on 12.08.2009 to the applicant institution under proviso to section 14 (3) (b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation on its behalf.
- 4. AND WHEREAS the applicant institution submitted its representation dated 07.09.2009, and the said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by Northern Regional Committee in its 149th meeting held on 13th 14th April 2009 which came to the conclusion that recognition/permission to the said institution be refused for the following reasons:

 The bills for purchasing equipments are submitted but the stock register where the purchased equipment are entered is not submitted.

The land register in the name of institution is on Khasra No. 112 and plot no.72, 73, 74 and 75 all these plots are purchased only for residential purpose but not for running B.ED. courses, the building plan submitted is for Khasra No. 568 / 2 and 569 and these do not match.

 The bills for purchase of books are submitted but the photocopy of accession register where the purchased books are entered is not submitted.

4 The playgrounds are still not developed hence the committee decides to refuse recognition to the institute for conducting for B.FD, course
