ORDER

WHEREAS in terms of Section **14(1)** of the NCTE Act, 1993 SHRI HANUMAT SHIKSHAN SANSTHAN PRASHIKSHAN MAHAVIDYALAYA, VILL - RAIPUR, POST - HAKEEMPUR, TEHSIL - KADIPUR, DISTT.-SULTANPUR,UTTAR PRADESH has submitted an application (**UP-3205**) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting **B.Ed. course** of **One year** duration with an annual intake of **100 (ONE HUNDRED ONLY)** students on 23.10.2008.

2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **Secondary Teacher Education Programme** such as instructional facilities, Infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the Programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section **14(3) (a)** of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to SHRI HANUMAT SHIKSHAN SANSTHAN PRASHIKSHAN MAHAVIDYALAYA, VILL - RAIPUR, POST - HAKEEMPUR, TEHSIL - KADIPUR, DISTT. - SULTANPUR, UTTAR PRADESH for conducting **B.Ed. Course** of Secondary (**level**) of **one year** duration with an annual intake of **100 (ONE HUNDRED)** students from the academic session **2009-2010** under clause 7(11) of NCTE Regulation, 2007 notified on 10.12.2007 subject to fulfillment of following conditions as per the clarification from the NCTE Hqtrs letter No. File No. - 48-3(1)/2008/NCTE(N&S) dated 01.10.2009:-

(a) The admissions of student shall be made only after affiliation by the examining body, before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic year 2009-2010, failing which the recognition will be effective from the session 2010-2011 only.

(b) Formal orders for recognition / permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University /Affiliating body.

4. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated jointly with an officer of the Northern Regional Committee.

5. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

6. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

7. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

8. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

9. If the institution contravenes any of the above conditions of the provisions of the NCTE Act, Rules, Regulations and orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

10. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

11. It was observed by the Regional Committee that the land is not in the name of the institution, as required under clause B(7) of Regulation 2007. Hence, it is required that the land is to be registered in the name of the institution on ownership basis i.e. bairnama, sale deed gift deed within six months failing to which recognition stands cancelled automatically.
