  - II. Formal orders for recognition/permission will operate for 2009-2010 only if the ement of 180 teaching days in the session is fulfilled as per calendar of the rsity/Affiliating Body.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern (tegional Committee).
