WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Teerthanker Mahaveer Institute of Management & Technology, Delhi Road, Moradabad- 244001, U.P., had submitted an application to the Northern Regional Committee of NCTE, Jelpur for grant of recognition/permission for starting M.Ed. Course of One year duration with an annual intake of 25 (Twenty Five Only) students on 06.03.2006.

- AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VIR videography were duly considered by the NRC in its 109th 2th Sitting Meeting held on 10th November 2006 and 11th to 12th November 2006 respectively, the committee decided to issue Conditional Letter of Recognition to the institution and accordingly conditional recognition order was issued vide NCTE letter no. F.NRC/NCTE/F-7/8356-70 Dated 14.11.2006.
- AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE, Jaipur and the matter was placed before NRC in its 141" Meeting held on 22" to 24th May 2009 and the committee decided to refuse the recognition for M.ED course of one year duration. Accordingly order was issued vide order no. F.NRC/NCTE/F73/UP-2103/141 MEETING/2009/8906-12 dated 27.08.2009. The above said institution, thereafter preferred an appeal dated 18.08.2009 to the NCTE, New Delhi. Under section 18 of the NCTE Act 1993 against the aforesaid order.
- AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was adequate ground to accept the appeal, and accordingly remanded back the matter to NCTE NRC with the direction to issue the order of recognition to the institution, in its order no. F.NO. 89-873/2009 -APPEAL
- AND WHEREAS the matter was again placed before the NRC NCTE in its 151" Meeting held on 20th to 21" October 2009 and the committee decided process the file as directed.
- NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Teerthanker Mahaveer Institute of Management & Technology, Delhi Road, Moradabad- 244001, U.P. for conducting M.ED course of PG (Level) of One year duration with an annual intake of 25 Students (Twenty Five only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 7007 notified on 10-12-2007 subject to fulfillment of the following conditions as per the clarification from the NCTE HQtrs letter No. File No. 48-3(1)/20/8/NCTE (NAS) dated 01/10/2009:
 - I. The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.
 - II. Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
