REFUSAL ORDER

WHEREAS in terms of Section **14(1)** of the NCTE Act, 1993 **MAHARANI LAXMI BAI COLLEGE OIF EDUCATION AND SCIENCE , M- BADAL AND CO., MAYUR APARTMENT , NEAR KUNJ BEHARI, MANDIR, JHANSI, U.P.** had applied for grant of recognition (UP-2428) for B.ED. Course of one year duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the Competent authority has constituted a Visiting Team to Visit the Institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 138th meeting held on 14th to 16th March 2009. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a show cause to the institution and asked the institution to following:-

- **CLU certificate is not enclosed.**
- **Building completion certificate is not enclosed.**
- **Land is in the name of Trust but not in the name of the Institution.**
- **Sufficient number of Computers for 100 students is not there.**
- **No supporting documents for hardware and software for Language Lab. is there.**
- **Photocopy of accession register is not there.**
- **No supporting document for purchase of encyclopedia.**

4. AND WHEREAS the applicant institution has submitted reply of the above said order. The matter was placed before Northern Regional Committee in its 141st meeting held on 22nd - 24th May, 2009. The committee observed that:-

- **CLU is not submitted.**
- **Building completion certificate from competent authority is not submitted.**
- **The Land is in the name of the Trust but not Institution.**

5. NOW THEREFORE grant of recognition to **MAHARANI LAXMI BAI COLLEGE OIF EDUCATION AND SCIENCE , M- BADAL AND CO., MAYUR APARTMENT , NEAR KUNJ BEHARI, MANDIR, JHANSI, U.P.** for the course in B.ED. in term of section 14(3) (b) of the NCTE Act, 1993 is hereby refused.
